



## 2022 MHA Health PAC Recommendations for Organization-run Campaigns

Thank you for conducting your Health PAC campaign as we work toward meeting our 2022 goal of \$400,000. Use the following recommendations to ensure a successful fundraising campaign within your organization. ### Solicitation and Contribution Recommendations

- **All Health PAC solicitation correspondence must be sent on personal or Health PAC stationery. Customizable sample materials are available online at [www.mhahealthpac.org](http://www.mhahealthpac.org).** All correspondence should be signed by the CEO; however, titles should be excluded on Health PAC solicitation materials.
- State and federal law allows the solicitation of salaried employees from MHA-member hospitals/health systems with the following responsibilities: policy-making, supervisory, managerial, professional, administrative/non-clerical and board members. A list of your organization's contributors from last year is available by request. Contact Stacy Dowdy ([sdowdy@mha.org](mailto:sdowdy@mha.org)) for more information.
- Below is a range of suggested contribution levels that you may wish to follow. However, any level of giving is greatly appreciated.

<b>Suggested contribution levels</b>	<b>Facility w/less than \$250 M in NPR</b>	<b>Facility w/more than \$250 M in NPR</b>
CEO and Trustees	\$1,000	\$2,000
Senior Vice President/VPs	\$750	\$1,000
Directors	\$350	\$500
Managers	\$150	\$350

- Send a second request within the first fourteen days of the month-long campaign to those individuals who have not responded to the first request.
- All checks should be made out to "**Health PAC.**" Health PAC cannot accept corporate/business checks. Contributions over \$20 must be written on personal checks, never hospital corporate, personal corporate or any other business-related check. Please do not send cash.
- A fully completed contribution card must accompany every contribution.
