



Maternal Levels of Care Survey – [REDACTED] What you need to know? For Providers

The Joint Commission is coming to do a Verification Survey to determine if we are eligible for a Level 4 (regional perinatal health care center) Maternal Levels of Care designation.

Chart Review: The surveyor will spend a few hours reviewing 5 open and 5 closed charts looking for documentation of care provided for an uncomplicated labor and delivery patient, spontaneous labor and birth, patient transition of care, patient undergoing c-section and high risk labor and delivery patient (e.g. pre-eclampsia, preterm labor, cat II or III tracing, shoulder dystocia, PPH).

Be prepared to speak to our processes (for example):

- Process for ordering common medication (e.g. Magnesium and Pitocin)
- Processes for common complications (e.g. PPRM, PTL, PPH)
- Co-management of critically ill patients in the birth center or in the ICU
- Management of placenta accreta spectrum patients
- Oversight and care of antepartum service

Provider Requirements:

- Board-certified or board-eligible obstetrician is always physically present onsite
- MFM care team with expertise in managing highly complex, critically ill, or unstable maternal patients. Includes co-management for all pregnant or pp patients in ICU
- Board-certified anesthesiologist with OB anesthesia fellowship training or experience is always physically present
- At least one of the following adult subspecialties are always readily available for consult and treatment needed onsite: neurosurgery, cardiac surg, or transplant surg

Quality Improvement Projects:

- Participating in OBI and MIAIM
- Current Quality/Safety focus areas include:
 - PPH: Goal <10%; risk assessment, hemorrhage carts, early uterotonics, optimizing Pitocin titration for IOL, debrief
 - C-section SSI: Goal <1%; implementing SSI bundle; optimizing preop antibiotics and redosing
 - NTSV c-section rate: Goal <28%; cat 2 algorithm, labor reviews, increasing nursing bedside support, awards for hard won cesarean sections
 - Sepsis screening/treatment: Goal >85% for screening and treatment
 - HTN: Goal treat severe HTN w/in 60 min >85% of the time; revised order sets/education for treatment of severe HTN
